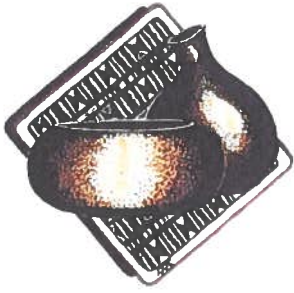

Balance Sheet

As of March 31, 2026, AHEC's total assets were \$3,278,126.46.

The fiscal year ends on June 30, 2026. A complete operating expenditure report for Fiscal Year 2025–2026 will be presented at the Fall Hālāwai.

Budget vs. Actual Operating Fund

Total Income reported as of March 31, 2026, was \$119,021.57.

Excluded from this amount are contributions to the Hua Mua Fund (FHB), Scholarship Offerings, Hua Mua Fund Draws, and General Fund Contributions.

Total income is \$1,498.43 below budget. However, income exceeded expenses by \$42,609.62 at the time of this report. Financial activity for April, May, and June has not yet been reported.

All committees remained within their approved budgets except for:

- Committee on Ministry
- Pacific Conference of Churches
- Postage, Materials, and Printing

The 'Aha o Nā Kahu budget reflects an overage; however, the committee generated \$1,709.12 in registration income from its training event, offsetting those expenses and keeping the committee within its approved budget allocation.

Investments

In fulfillment of the fiduciary responsibilities of the Pū'ukū, regular communication with Generations Investment Services continues to provide timely and accurate information regarding AHEC's investments.

During the pandemic years, investment values declined by:

- Redress Fund: (\$219,705.99)
- Hua Mua Fund: (\$60,235.95)

These losses were reported at the 2023 'Aha Nā Kai 'Ewalu.

Since then, both investments have recovered significantly. As reported at the 2026 Spring Hālāwai, investment gains totaled:

- Redress Fund: \$330,675.65
- Hua Mua Fund: \$60,235.29

After contacting Randy Garrett of Generations Investment Services regarding current economic conditions under the present administration, he provided the following response on April 7, 2026:

“We expect financial market volatility to remain elevated as a result of the ever-changing trade and military policies of the administration. Despite this reality, financial markets have remained remarkably resilient when viewed over a 12-month timeframe. It is certainly possible that matters can worsen and lead to greater market declines; however, AHEC's asset allocations are well-positioned to navigate current challenges.”

Historical Background

In 1993, President Dr. Paul Sherry of the United Church of Christ (UCC) delivered a historic apology at Kaumakapili Church in Honolulu. He apologized for the complicity of 19th-century missionaries in the 1893 overthrow of the Hawaiian Monarchy and Queen Lili'uokalani.

From that historic moment, the Association of Hawaiian Evangelical Churches (AHEC) was established, along with the creation of a one-million-dollar Redress Fund.

The Na Lima Ho'ike "E" Program Committee receives, reviews, and evaluates grant applications submitted by Hawaiian churches throughout the pae 'āina. Grant awards are distributed through the Redress Fund account to support ministry, mission, and community projects.

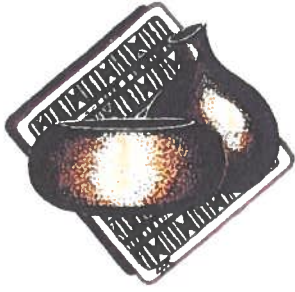

Finance Committee Report

As the new fiscal year approaches, the increasing demand for financial resources to support committee work and new projects requires an increase in the proposed budget for Fiscal Year 2026–2027.

The proposed increase is \$20,000, bringing the total draw from the Redress Fund to \$120,000.

The committee has maintained:

- A draw of \$50,000–\$60,000 annually since 2018.
- An increased draw of \$100,000 during fiscal years 2024 and 2025.

Over the years, a total of \$500,000 has been withdrawn toward the annual budget. Despite these withdrawals, the investment funds have increased by nearly one million dollars.

With a regulated and stable budget, the actual investment balances are as follows:

- Beginning of 2017: \$1,617,366
- End of 2025: \$2,614,162

Per the AHEC Standard Operating Procedures (SOP) for the Redress Fund, a 3%–5% annual draw is permitted. As long as the balance remains stable without significant decline, a 5% draw would be permissible.

Purpose Statement – Pastor’s Retreat

This retreat is designed to nurture the spiritual, emotional, and relational well-being of those who shepherd others. Through prayer, reflection, fellowship, and the study of God’s Word, pastors are encouraged to deepen their personal walk with Christ, receive encouragement from fellow leaders, and be refreshed for continued faithful service in ministry.

Mission Statement – Pastor’s Retreat

The mission of the Pastor’s Retreat is to **strengthen and equip pastors for faithful leadership** by fostering spiritual renewal, encouraging wholehearted fellowship, and cultivating a deeper dependence on the ‘Uhane Hemolele. The retreat seeks to motivate pastors to lead with renewed vision, spiritual vitality, and a commitment to healthy, Christ-centered ministry within their congregations and communities.

Pastor’s Retreat Theme

“Renewed to Serve”

Kako‘o Hale Pule — One-Page Summary

Purpose

Support **Hawaiian churches across the pae ‘āina** with small-scale maintenance that protects our hale pule and strengthens relationships. Through kōkua, we create a **safe, healing, spiritually grounded space** where unity and fellowship deepen our walk with God

Scope

- Minor repairs, preventative maintenance, small carpentry, non-hazardous electrical.
- Aesthetic upkeep, **including painting with rollers and brushes.**
- Urgent small issues.
- **AHEC funding limit: \$2,000 per project.**
- **No major projects;** excludes structural, major electrical/plumbing, roofing, hazardous materials, **or any work requiring licensed professionals.**

Funding

- AHEC covers up to **\$2,000** (materials, supplies, contractor fees).
- Travel costs count toward the limit.
- Churches cover all costs above \$2,000.

Island-Based Missional Teams

- Each island forms its own team to reduce travel costs and strengthen local relationships.
- Inter-island travel only when necessary and only if the church covers costs beyond the AHEC limit.

Safety

- Volunteers work within skill level.
- No work above 6 ft without proper equipment.
- No hazardous or unsafe electrical tasks.

Process

1. Request submitted with description, photos, urgency, contact.
2. Initial review within 7 days.
3. Site assessment for safety, scope, and cost.
4. Cost confirmation (church approval required if > \$2,000).
5. Approval by committee/Pu‘uku.
6. Scheduling with island team.
7. Work completed within safety guidelines.
8. Documentation (photos, costs, hours, follow-up).
9. Reporting quarterly to BOD; summary at each Hālāwai.
10. Evaluation every six months.

1. Mission & Kuleana of AHEC

PAPA MAKUA YEAR-END REPORT – 2025-2026

As we come to the close of another year, serving as Papa Makua within our association has revealed both the profound challenges and enduring rewards that made this year a blessing. We've walked alongside our congregations through seasons of uncertainty, grief, transition, and spiritual testing, yet, we have witnessed lives transformed, faith renewed, the beauty of unity and communities strengthened through the power of God. *"Let us not become weary in doing good, for at the proper time we will reap a harvest if we do not give up."* — Galatians 6:9 As we look toward the coming year, may we continue to lead with humility, serve with compassion, draw strength from the Lord and walk faithfully together.

NA HALAWAI (Meetings)

- I attended Church On Ministry (C.O.M.); AHEC Board of Directors and AHEC Executive Committee monthly meetings as scheduled and managed the zoom meetings.
- **HO'OKOLOKOLO COMMITTEE** – I have been active in seeking archiving and digitizing efforts for the artifacts of our discovery. Efforts for this goal continues through communication and zoom meetings with the Native American Boarding School Coalition and its **Digital Archive Director, Ms. Fallon Carey**. Currently, in April, I was informed that NABS has been undergoing funding cutbacks and management changes that have slowed our progress together. Additionally, **Christian American Indian Ministries (CAIM)** has begun communications with AHEC and actively incorporated the setting up of a **CAIM/AHEC Task Force** to work together on the Boarding Schools issues and Doctrine of Discovery. This doctrine accorded Christian nations the right to take land away from indigenous peoples, paying for it with the gift of religious conversion. An October meeting in Black River Falls, Wisconsin is in the planning.
- **HO'OLALA COMMITTEE** – I am encouraged that after a long period of inactivity, one of our church leaders, Desmond Haumea from Kalapana Maunakea First Hawaiian Church, has come forward to take on this task of strategic planning for the future of AHEC,
HO'OLA I KA 'AINA COMMITTEE - Under the leadership of Kahu Ron Fujiyoshi, this committee continues to serve requests for kokua and clarity regarding lands, titles and deeds. I initiated a meeting between this committee and Andy Bunn, HCUCF Foundation Director last year on **June 23**, and opportunities were given to this committee to research all records pertaining to lands, titles and deeds of churches at the HCUCF office.

NA HUI (Partnerships)

- I am active as a member of the **National American Boarding Schools Coalition** for justice, truth and healing, and the shared historical trauma of boarding schools. In the **UCC Rural and Small Town Church and Ministries Coalition**, I continue to participate in the National Gathering of Meetings held quarterly. We are recognized as a first member of Hawai'i of the **Pacific Conference of Churches**. Under the guidance of General Secretary, James Baghwan, AHEC continues to support initiatives of self-governance and self-determination throughout the Pasifika Household of God. In October, I was able to travel and gather with leaders in Samoa, Fiji, New Caledonia and Australia. While in Fiji, I was able to attend one of the Anglican churches and met with its Archbishop. On behalf of AHEC, I presented a Hawaiian stole, as well as Dr. Baghwan. I was also able to visit the Pacific Communities University (PCU) located in Fiji, where numerous students come for seminary education. I also support the **Pacific Conference of Churches Regional Ecumenical Youth Council (REYC)** and assist in sending youth leaders to leadership development opportunities with other youth throughout the Pacific. My participation and partnership as the UCC representative on the **World Council of Churches** remains active. In support of our partnership with the **Pacific Asian American Ministries (PAAM)**, I was able to engage with the **Micronesian Council of The UCC** executive officers of the various Micronesian churches.. I will be attending the **PAAM Convocation** to be held in Irvine, California from June 24-26 and have begun conversations with **COREM (Council for Racial and Ethnic Ministries)** leadership in considering a possible partnership. **Harvest Family Life Hawaii (foster care)**, **Aloha Ke Akua Ministries (homelessness)**, **Henry Maunakea Center for Discernment and Church Development**, and **Christian Voice Hawaii** are other partnerships that I had initiated, including an AHEC brochure

PILI LEHULEHU (Public Relations)

- **HARVARD UNIVERSITY** – I participated in a zoom meeting on the topic of church polity with students attending Harvard University – **December 18.**
- **KEANU SAI:** I continue to communicate with Keanu Sai, Minister of Foreign Affairs, who has been a supporter of AHEC regarding updates on the recognition of the Hawaiian Kingdom and the Council of Regency. Partnership discussions were made into becoming an active part of AHEC in the future.
- **QUEEN LILIUOKALANI SERVICE** - I participated in this event held at Mauna Ala in Nu'uauu – **January 29.**

KAHU I KE KAHU (Pastor to Pastor)

- **HCUCC OAHU ASSOCIATION PASTORS MEETING** - Since November, I have been attending the Oahu Clergy monthly meetings and find it very rewarding and resourceful in developing relationships, as well as listening to the challenges and rewards that pastors have endured. I have also been invited to the **Kaua'i Association** meetings.
- **ANTI-RACISM TRAINING** –I attended this workshop led by Kahu Aldred on November **15 & 22nd.**
- **MOKUAUKAUA RE-DEDICATION CEREMONY** – Attended this event – **November 21-22.**
- **BLUE CHRISTMAS - December 17** – Participated in the Blue Christmas Candlelight service held at Ewa Community Church and at Kaumakapili Church -**December 21** and participated as a narrator for the Christmas Story drama performance for the Nu'uauu Seventh-Day Adventist Church – **Dec.19-20.**
- **KAHU JOHN DEMELLO – January 13** - I attended a meeting with Kahu Michael Warrend, Luna Ho'omalua Joyclyn Costa and incoming pastor, Kahu John DeMello on Maui to discuss the transition of his church into AHEC. **Report for ‘Aha Nā Kai ‘Ewalu
Rev. Jonathan C. Roach, Ph.D., ACM
May 1, 2025 through May 1, 2026**

Aloha Kākou,

I. Introduction:

This year has been a blur of activity! After last June’s ‘Aha Pae‘āina, it was off to General Synod, then our Conference Minister, David, was on sabbatical, and every team and committee was gearing up for the fall.

The fall was a time of lament on Hawai‘i Island. The sanctuary building of Helani Congregational Church was destroyed by fire. Leaders such as Sharon Matsuyama and Kahu Diane Hultman were and continue to struggle with significant health problems, congregations are struggling to pay the bills and keep the doors open, and we are mourning the passing of our beloved Kahu Charles Mahina Kaupiko, Kahu Daniel Kawaha, and Uncle Harry Aiu, the long-serving moderator of Helani Congregational Church. But there have been rich and powerful moments of ministry in the midst of this lament.

Our COM Chairs hosted an important Anti-Racism Training with Dr. Ray Aldred in November, the Pastoral Leaders Retreat Planning Group offered a great retreat with Dr. Manulani Meyer and Larissa Marks, and the Innovation and Engagement Missional Team presented three great ministry labs. In addition, we celebrated the installation of ten kahu pono at Kawaiaha‘o Church, enjoyed a great worship service at Mokuaikaua as they re-opened their sanctuary building after six years of fund raising and remodeling, and danced for joy with the ordination of Kahu Melveen Kaupiko and the installations of Kahu John Leong and Kahu Rosalind Ioane. I was also able to attend the 100th Anniversary celebration of Kuhio Chapel to support their wonderful ministry and join the Pū‘a Foundation for their Open House and see the amazing progress at their Papali Street property.

In addition, I have been hard at work with the COM Chairs to facilitate a joint UCC History, Theology, and Polity class which we have scheduled to be offered in August and September. I am grateful for the over 30 clergy and lay leaders from around the Conference who provided feedback and insights into this class’s objectives and content.

II. My duties include the following essential functions:

1. Work collaboratively and openly with all Conference staff.
2. Support and resource all Hawai‘i Conference churches and ministers.
3. Work in partnership with the Papa Makua for support of the Association of Hawaiian Evangelical Churches’ congregations.

4. Support and resource Hawai'i Island Association's Board and Committee on Ministry.
5. Support and resource the Association of Hawaiian Evangelical Churches Board and Committee on Ministry.
6. Spearhead Search and Call support of congregations in pastoral transition.
7. Staff and resource missional teams of the Conference Council and staff as assigned.
 - a. Editorial Team
 - b. Committee on Ministry Chairs
 - c. Pastoral Leadership Retreat Planning Team
 - d. Innovation and Engagement Missional Team
 - e. Justice and Witness Missional Team (until December 2025)
8. Ensure that Conference files of churches, ministers, and associations are kept current with minutes and all supporting documentation.
9. Attend meetings, as assigned, of Conference staff, Conference Council, associations, and ecumenical events.
10. Perform other duties as assigned by the Conference Minister.

III. Change in Essential Functions:

With the increasing demands of Search & Call, the responsibility of being the liaison for our Justice and Witness Missional Team was removed from my duties by the Conference Minister in December. Although I will miss working with this great team, I needed the time to focus upon Search & Call.

IV. Bill 60:

Last June while we were at the 'Aha Pae'āina, Hawai'i County Council brought forward Bill 60 with the intent to provide more regulation over houses of worship in the County Code. In its first version, this bill would have even set hours of operations for churches. Working with Interfaith Communities in Action, an organization that I am the current president of, and other faith leaders, we started to educate and organize our members and to open dialogue with our County Council. After three revisions of the bill, numerous phone calls and emails, and an in-person meeting with the Planning Department and Councilmember Ashley Kierkiewicz, not only were we able to get the hours of operation dropped completely, but also we got changes to the definition of meeting facilities (which houses of worship now fall under in the code), changes to the definition of events (which is now called special events and only includes events outside the normal range of activities), and a carve out for house churches that will not need permits if they are under 25 in attendance and met two times or less per week.

V. Search and Call:

I am currently serving as the Conference support person for Nu'uaniu Congregational Church, Waikeola Congregational Church, Haili Congregational Church, Wai'oli

Hui‘ia Church, Makiki Christian Church, Church of the Crossroads, Koolauhuiia Protestant Church, UCC Judd Street, ‘Iao UCC, First Chinese Church of Christ, Waialua UCC, United Community Church, Hawai‘i Kai UCC, Lāna‘i Union Church, and Filipino UCC.

In the last 12 months, I reviewed profiles of 77 UCC clergy, met with 34 clergy via Zoom or in person to discuss ministry opportunities, and worked with 23 clergy outside of the UCC who were interested in ministry at one of our congregations.

Since last June, we have welcomed:

1. Pearl City Community Church has called Rev. Jon Lilley who started Sunday, March 15
2. Keawala‘i Congregational Church has called Rev. Mitch Nelson who started Sunday, February 15
3. Makawao Union Church has called Martha-Lee Bohn who is seeking authorization for lay ministerial standing and who has already started
4. ‘Opihikao Congregational Church has called Frank Mulec who is seeking authorization for licensed ministerial standing and who has already started

VI. Meetings and Support

Over the last 12 months, I have participated in 414 meetings and events for my job duties and responsibilities. In addition, during David Popham’s sabbatical, I covered additional meetings with the O’ahu COM, Micronesian Committee, and ‘Aha O Nā Mokupuni ‘O Maui, Moloka‘i a Me Lāna‘i COM. 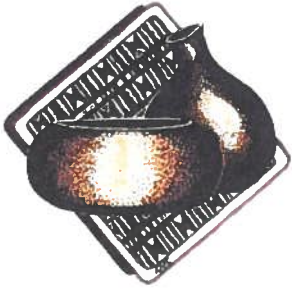

Subject: Non-Substantive Corrections to Article VI, Section 6.2 – Committee on Ministry

Date of Board Approval: April 4, 2026

Purpose of Report

The Bylaws Committee respectfully submits this report to the Membership Churches of the Association of Hawaiian Evangelical Churches (AHEC) for transparency and official recordkeeping. This report documents non-substantive corrections approved by the Board of Directors to Article VI, Section 6.2, Committee on Ministry, along with related technical corrections throughout the Bylaws.

Summary of Board Action

At its meeting held on April 4, 2026, the Board of Directors approved non-substantive corrections to Article VI, Section 6.2.1 of the AHEC Bylaws, as recommended by the Bylaws Committee.

These revisions were limited to clarification, grammar, formatting, numbering, and structural consistency. The corrections did not alter the intent, governance structure, or policy direction of the Bylaws. The purpose of these updates was to improve clarity, readability, and internal consistency.

Revised Bylaw Provision

The corrected Article VI, Section 6.2.1 now reads as follows:

ARTICLE VI – COMMITTEES

6.2 COMMITTEE ON MINISTRY

6.2.1 The Committee on Ministry shall consist of seven (7) members; three (3) of whom shall be lay persons, and shall include one or two (1–2) persons from each island as stated in Article 4.1.2. Members shall serve staggered terms, shall be nominated by the Nominating Committee, and elected at the ‘Aha Nā Kai ‘Ewalu. Members shall serve a term of three (3) years beginning July 1 of the year elected and may serve no more than two consecutive terms. In the event of a vacancy, the Board of Directors shall appoint a replacement to complete the unexpired term.

Nature of Corrections

The approved corrections include:

- Standardization of bylaw language for consistency
- Clarification of membership composition and island representation
- Alignment of nomination and election procedures with existing governance practice
- Clarification of term length, term limits, and effective service dates
- Clarification of vacancy appointment authority by the Board of Directors
- Formatting and technical corrections for consistency across the Bylaw

Governance Review

These corrections are technical and clarifying in nature and do not constitute substantive amendments to the Bylaws. As such, approval by the Board of Directors was sufficient.

In accordance with Article XIII of the Bylaws, membership approval was not required, as there was no alteration to governance, intent, or policy.

Official Record

This report is submitted to the Annual Meeting of the Membership Churches to ensure transparency and proper documentation of Board action.

ARTICLE I – MEMBERSHIP

1.1 **MEMBERSHIP** The Association shall have two (2) classes of members. The designation of such class and the qualifications and rights of the members of such class shall be as follows:

1.1.1 **REGULAR MEMBERSHIP** The Regular Membership of this Association shall include the following:

1.1.1.1 Any church within the boundaries of this Association that expresses its Christian Faith in native Hawaiian cultural forms as expressed in the Constitution of this Association.

1.1.1.2 Any Kahu who holds standing in this Association.

1.1.1.3 The officers of this Association.

1.1.1.4 Chairperson of all Committees in this Association.

1.1.1.5 Voting Rights of Members defined in Section 1.3

1.1.2 **ASSOCIATE MEMBERSHIP** The following persons serving in an AHEC church shall be Associate Members of this Association upon a majority vote of any regular members presiding at any meeting of the membership:

1.1.2.1 A minister of the United Church of Christ holding standing in an Association or Conference other than the Hawai'i Conference.

1.1.2.2 The Conference Minister/Associate Conference Minister of the Hawai'i Conference United Church of Christ. But unless they otherwise have standing under 1.1.1.

1.1.2.3 A minister serving a church under Privilege of Call.

1.1.2.4 An ordained minister holding standing in another denomination while serving as a minister in a church of an Association of the Hawai'i Conference United Church of Christ.

1.1.2.5 A member in good standing of any Conference Church of the United Church of Christ.

1.1.2.6 Such other persons who may be designated as Associated Members by the membership

1.1.2.7 Recognized Partnership Ministries as defined by Article II herein.

1.1.2.8 Voting Rights of Members defined in Section 1.3.4

1.1.3 **AUTONOMY OF MEMBER CHURCHES** The Association recognizes the autonomy of the local church. Therefore, a church that is a member of this Association shall have a voice in the affairs of this Association and shall be expected to enter fully into the life and work of this Association, to be faithful to that life, and to serve in its mission.

1.2 **PRIVILEGES AND RESPONSIBILITY OF MEMBERSHIP** All members of this Association shall have a voice in the affairs of this Association and shall be expected to enter fully into the life and work of this Association, to be faithful to that life, and to serve in its mission.

1.2.1 **NA EKALIESIA (Churches)**

1.2.1.1 **Mau Noa (Freedom)** The autonomy of the local church is inherent. Nothing in the Constitution and Bylaws of this Association shall destroy or limit the right of any local church.

1.2.1.2 **Mau 'Ohana (Fellowship)** All actions, decisions, and advisories emanating from the 'Aha Nui (General Synod) and the 'Aha Pae'aina and the 'Aha Na Kai 'Ewalu shall be given proper and prayerful consideration by every member church.

1.2.1.3 **Mau Kuleana (Responsibility)** Each church is expected to fulfill its membership responsibility by paying the per capita assessments as determined by these Bylaws and/or by the 'Aha Na Kai 'Ewalu to continue membership.

1.2.2 **NA KAHU (Ministers)** This Association recognizes that God calls certain persons to full and part-time service for various forms of ministry in the Church. This calling is 'apono (affirmed) by ordination and/or other appropriate service of installation refer to applicable portions of the Buke Lawelima with reference to the Manual on Ministry as needed and respect Hawaiian Cultural Values make appropriate recommendation (s) to the Association The Kahu of the Association, then, shall be recognized with the title affirmed by the rite of installation.

1.2.2.1 **Kahu La'a** The Kahu La'a, having fulfilled the requirements for ordination shall refer to applicable portions of the Buke Lawelima

with reference to the Manual on Ministry as needed and respect Hawaiian Cultural Values make appropriate recommendation (s) to the Association shall be entitled to all the rights and privileges pertaining to that office and be expected to participate fully in the life and work of the Association.

1.2.2.2 **Kahu Pono** The Kahu Pono, having fulfilled the requirements for recognition as a Minister sanctioned by the Association and/or having fulfilled the requirements for licensing as a Licensed Minister shall refer to applicable portions of the Buke Lawelima with reference to the Manual on Ministry as needed and respect Hawaiian Cultural Values make appropriate recommendation (s) to the Association shall be entitled to all the rights and privileges pertaining to that office and be expected to participate fully in the life and work of the Association.

1.2.2.3 **Kahu Hiki** The Kahu Hiki, serving a Church of the Association in a specific ministry shall be entitled to all the rights and privileges pertaining to that office and be expected to participate fully in the life and work of the Association.

1.3 VOTING RIGHTS OF MEMBERS

1.3.1 Each church, as defined in Section 1.1.1.1 of these Bylaws, shall have one vote for each delegate that a church is entitled to send to a meeting as defined in Article III hereof.

1.3.2 Kahu, as defined in Section 1.2.2.1 and 1.2.2.2 of these Bylaws representing a church shall have one (1) vote per church.

1.3.3 All Retired Kahu in good standing with this Association shall have one (1) vote.

1.3.4 All members of the Board of Directors or representative of a Partnership Ministry: State Sunday School Association, Hawaii Pacific Islander and Asian American Ministries, Pacific Justice and Reconciliation Center, Kamehameha Schools, and the Christian Endeavor of Hawaii; and chairpersons of the Standing Committees shall each have one (1) vote.

1.3.5 Associate Members of this Association, and any new representative of a Partnership Ministry, shall have a right to voice their thoughts and opinions in the affairs of this Association but shall not have the right to vote.

1.3.6 Members must be present at a meeting to vote.

- 1.4 TERMINATION OF MEMBERSHIP** The Board of Directors, by affirmative vote of two-thirds (2/3) of all of the members of the Board, may suspend or expel a member for cause after an appropriate hearing, and may, by a majority vote of those present at any regularly constituted meeting, terminate the membership of any member who becomes ineligible for membership. A church that does not meet its Mau Kuleana under Section 1.2.1.3 herein and for which a ho'oponopono process by the Aha Nā Kai 'Ewalu has failed, in the sole discretion of the Board of Directors, to redress the problem may be expelled from membership as established in this Section 1.4.
- 1.5 RESIGNATION OF MEMBER** Any member may resign from the membership in this Association by filing a written statement to that effect with the Secretary, but such termination shall not relieve the member of the obligation to pay any dues, assessments, or other charges accrued and unpaid.

ARTICLE II-PARTNERSHIP MINISTRIES

- 2.1 RECOGNITION OF PARTNERSHIP MINISTRIES** The Association, in the event that another organization agrees with the purposes of the Association as stated in the Constitution of this Association, may recognize such an organization as a Partnership Ministry and by a majority vote of the Board of Directors invite such an organization to become an Associate Member of this Association.
- 2.2 ROLE OF PARTNERSHIP MINISTRIES AS MEMBERS** Partnership Ministries, which have standing in this Association as recognized under Section 2.1 herein, shall promote the purposes and programs of this Association and cooperate in its mission.

ARTICLE III - MEETINGS OF MEMBERS

- 3.1 'AHA NĀ KAI 'EWALU (Annual Meeting)** The Aha Nā Kai 'Ewalu shall be the Annual Meeting of the Association and shall be held in the month of June in conjunction with the 'Aha Pae'āina (the Annual Meeting) of the Hawai'i Conference and prior to the 'Aha Makua (Business Session of the Annual Meeting).
- 3.2 'AHA HALAWAI (Regular Meetings)** Two regular meetings shall be held during the months of February and October of each year, with dates to be determined by the Board of Directors.
- 3.3 'AHA KUKA (Ecclesiastical Council Meetings)** The Board of Directors shall call an Ecclesiastical Council at the request of a majority of the members of the Committee on Ministry. An Ecclesiastical Council is a meeting of the Association called for the purpose of deciding ordained ministry and state of the churches.
- 3.4 'AHA KUKA (Ecclesiastical Council Meetings)** The Board of Directors shall call an Ecclesiastical Council at the request of a majority of the members of the Committee on Ministry. An Ecclesiastical Council is a meeting of the Association called for the purpose of deciding ordained ministry and state of the churches.

- 3.5 'AHA LA'A (Special Meeting)** A Special meeting(s) for fellowship or business of the Association may be called by the Board of Directors at the request of seven (7) or more churches.
- 3.6 PLACE OF MEETINGS** The Board of Directors may designate any place, either within or without the State of Hawai'i, as the place of meeting for any 'Aha Na Kai 'Ewalu, 'Aha Halawai, or 'Aha Kuka called by the Board of Directors. If no designation is made or if an 'Aha La'a be otherwise called, the place of meeting shall be the registered office of the Association in the State of Hawai'i; but, if all of the members shall meet at any time and place, either within or without call or notice, and at such meeting any corporate action may be taken.
- 3.7 KAHEA ANA (Notification)** The Board of Directors shall provide written notice of all meetings to the membership at least thirty (30) days prior to the date of the meeting. Said notice shall state the place, day, and hour of the meeting, as well as the purpose or purposes for which the meeting is called, and shall be delivered either personally, email or by mail.
- 3.8 KAHU ANA (Representation)** Each church shall be represented by two (2) lay delegates and a youth/young adult delegate who is 35 years of age or less at the time of meeting. Those Churches with more than one hundred (100) members shall be entitled to one (1) delegate for each additional fifty (50) or major fraction thereof. The total delegates from any one church shall not exceed seven (7). Members of the Board of Directors, representatives of recognized Partnership Ministries and Chairpersons of Standing Committees shall represent themselves.
- 3.9 KE KOHO ANA (Quorum)** A quorum for the transaction of business shall be declared when at least one-third (1/3) of the churches in the Association are represented.

ARTICLE IV-BOARD OF DIRECTORS

- 4.1 COMPOSITION OF THE BOARD OF DIRECTORS** There shall be a Board of Directors consisting of the following: The Officers of the Association;
- 4.1.2 One director from O'ahu, Kaua'i, East Maui, West Maui, East Hawai'i, West Hawai'i, and Moloka'i, who shall be elected at the Annual Meeting;
- 4.1.3 One representative from each of the following: State Sunday School Association; Hawai'i Pacific Islander and Asian American Ministries; Pacific Justice and Reconciliation Center; Kamehameha Schools; and Christian Endeavor of Hawai'i.
- 4.1.4 The chairpersons of standing committees.
- 4.2 TENURE** Each Director shall serve for a term of two (2) years and may not serve for more than (3) consecutive terms.

4.3 DUTIES AND RESPONSIBILITIES

- 4.3.1 The purpose of the Board of Directors is to set the direction for the Association in the pursuit of its purpose and mission and to submit to the Association for its approval at the 'Aha Na Kai 'Ewalu the program plans and budget for the attainment of the Association's goals.
- 4.3.2 The Board of Directors shall have the power to fill any vacancies in the Board or its offices, committees, and positions for the interim period until the next scheduled election or appointment by the affirmative vote of the majority of the Board of Directors then serving.
- 4.3.3 The Board of Directors shall issue calls for meetings of the Association.
- 4.3.4 The Board of Directors shall act for the Association between Association meetings and shall carry out those as instructed by the Association.
- 4.3.5 The Board of Directors shall have the power to designate any officer or agent to enter into any contract and deliver any instrument in the name of or on behalf of the Association provided such authority should be confined to specific instances.
- 4.3.6 The Board may endorse to the Conference Nominating Committee a candidate for the Hawai'i General Synod delegation.

4.4 MEETINGS OF THE BOARD

- 4.4.1 **Regular Meetings** The Board shall meet as needed and not less than four (4) times a year. A regular meeting of the Board of Directors shall be held without other notice than these Bylaws. The Board of Directors may provide by resolution the time and a place for holding additional meetings of the Board without other notice than such resolution. The Board may call for meetings and voting by video conferencing or by telephone conferencing, and may permit electronic voting.
- 4.4.2 **Special Meetings** Special meetings of the Board of Directors may be called by or at the request of the president or any three directors. The person or persons authorized to call special meetings of the Board may fix any place, either within or without the **Pae'āina** Hawai'i, as the place for holding any special meeting of the Board called by them. The discussion and resolution will be limited to the item(s) which the Special Meeting was called for.
- 4.4.3 **Quorum** At all meetings of the Board of Directors a majority of the directors shall be necessary and sufficient to constitute a quorum for the

transaction of business and the act of a majority of the Directors present at any meeting at which there is a quorum shall be the act of the Board of

Directors, except as may be otherwise specifically provided by statute or by these Bylaws.

4.4.4 **Notice** Notice of any special meeting of the Board of Directors shall be given at least five (5) days previously thereto by written notice delivered personally or sent by electronic correspondence to each director at his or her address as shown by the records of the Association. Any director may waive notice of any meeting. The attendance of a director at any meeting shall constitute a waiver of notice of such meeting, except where a director attends a meeting for the express purpose of objecting to the transaction of any business because the meeting is not lawfully called or convened. Neither the business to be transacted at, nor the purpose of, any regular or special meeting of the Board need to be specified in the notice or waiver of notice of such meeting, unless specifically required by law or by these Bylaws.

4.5 **Compensation and Reimbursement** Directors shall not receive any stated salary for their services as such, but by resolution of the Board reasonable expenses of attendance, if any, may be allowed for attendance at such regular or special meeting of the Board. The Board of Directors shall have power in its discretion to contract for and pay to directors rendering unusual or exceptional services to the Association special compensation appropriate to the value of such services.

4.6 **REMOVAL** Any Director may be removed from office at any time with or without cause by the affirmative vote of the majority of votes entitled to vote at any special meeting of the Board of Directors called for such a purpose.

4.7 **RESIGNATION** Any director may resign at any time by giving written notice of such resignation to the Board of Directors.

ARTICLE V-OFFICERS

5.1 **OFFICERS** The Officers of this Association shall be members in good standing of a church that is a member of this Association. There shall be a PAPA MAKUA (Association Minister), a LUNA HO'OMALU (President), a LUNA HO'OMALU HOPE (Vice President), a KAKAU 'OLELO (Secretary), and a PU'UKU (Treasurer). Only one (1) Executive Officer per church. The duties of the Officers shall be as follows:

5.1.1 **The PAPA MAKUA**

5.1.1.1 Shall be the spiritual leader of the Association and its chief executive and administrative officer, having general supervision over the work of the Association under the direction of the Board of Directors;

5.1.1.2 Shall be an ex-officio member of the Board of Directors and all other committees of the Association unless there are specific provisions to the contrary stated in these Bylaws;

- 5.1.1.3 Shall serve as an ex-officio member of the Nominating Committee, without vote;
- 5.1.1.4 Shall be a minister in good standing of the United Church of Christ, nominated by the Board of Directors and elected by the Association at the 'Aha Na Kai 'Ewalu;
- 5.1.1.5 Shall serve a term of office of two (2) years, and there shall be no limit to the number of terms that may be served;
- 5.1.1.6 Shall be representative of the Association on the Conference Council of the Hawai'i Conference United Church of Christ; and,
- 5.1.1.7 Shall be accountable to the Association.

5.1.2 **The LUNA HO'OMALU**

- 5.1.2.1 Shall preside at meetings of the Association , the Executive Committee, the Board of Directors, and the 'Aha Na Kai 'Ewalu;
- 5.1.2.2 In consultation with the Association officers, shall propose the direction for the Association to the Board of Directors for its approval, and shall make an annual report to the Board of Directors and to the 'Aha Na Kai 'Ewalu;
- 5.1.2.3 Shall be an ex-officio member of all committees except the Nominating Committee and except where provisions to the contrary may be stated in these Bylaws;
- 5.1.2.4 May be elected for two (2) consecutive terms totaling four (4) years, and may be elected to another term if one (1) year has elapsed from the time that the person ended the prior term;
- 5.1.2.5 Shall represent the Association on the Conference Council of the Hawai'i Conference UCC;
- 5.1.2.6 Shall execute all contracts and other documents as ordered by the Association or Board of Directors; and,
- 5.1.2.7 Shall in alternating terms be a Kahu and a layperson.
- 5.1.2.8 After extensive searching, in the event an eligible nominee is not available, then a nominee from the other category may be presented.

5.1.3 **The LUNA HO'OMALU HOPE**

- 5.1.3.1 Shall perform the duties of Luna Ho'omalulu in the event of his or

her absence or inability to act, and such other duties as may be assigned by the Board of Directors; and,

- 5.1.3.2 May be elected for two (2) consecutive terms totaling four (4) years, and may be elected to another term if one (1) year has elapsed from the time that the person ended the prior term.

5.1.4 **The KĀKAU 'ŌLELO**

- 5.1.4.1 Shall maintain a permanent record of all meetings of the Association, Board of Directors, Executive Committee, and the 'Aha Na Kai 'Ewalu; Minutes are to be completed and sent to the Executive Committee within thirty (30) days.
- 5.1.4.2 Shall make an annual report to the Association including a roll call of all churches and Kahu participating in the Association and shall report all changes to the Association;
- 5.1.4.3 Shall issue notice of meetings as provided for in the Constitution and Bylaws; annually publish a roster of officers, directors, standing committee chairpersons and its members, and perform such other duties as may be required; and,
- 5.1.4.4 Shall serve a term of two (2) years and may be elected for two (2) consecutive terms totaling four (4) years, or until his / or her successor is elected and installed.

5.1.5 **The PU'UKŪ**

- 5.1.5.1 Shall receive all assets, contributions and assessments made for the work of the Association;
- 5.1.5.2 Shall make payments of funds as may be directed by the Board of the Directors or Association or donor gifts;
- 5.1.5.3 Shall at all time keep an accurate record of all transactions involving the various accounts entrusted to his or her care;
- 5.1.5.4 Shall submit a monthly report of the financial operations of the Association to the Board of Directors, and a full report to the 'Aha Na Kai 'Ewalu;
- 5.1.5.5 Shall perform other duties that usually pertain to the office or as directed by the Board of Directors;
- 5.1.5.6 Shall be an ex-officio member of the Finance Committee; and,
- 5.1.5.7 Shall serve a term of two (2) years and May be elected for two (2) consecutive terms totaling four (4) or until his / or her

successor is elected and installed.

5.2 **ELECTION OF OFFICERS** Officers shall be elected for the terms designated in Article 5.1 and installed at the Annual Meeting of the Association.

5.2.1 An election shall be held at the 'Aha Na Kai 'Ewalu every year.

5.2.2 Election shall be either by secret ballot or, where there is only one (1) nominee for an office, by voice vote. A majority of the votes shall be sufficient to carry the election.

5.3 Any officer may be removed by a majority vote of the membership whenever in its judgment the best interest of the Association would be served thereby, except for the Papa Makua who may be removed by a majority vote of the Board of Directors.

5.4 **RESIGNATION** Any officer may resign upon submitting ninety (90) days' notice to the Kākau 'Ōlelo of the Association.

ARTICLE VI-COMMITTEES

The Standing Committees of this Association shall be the Executive Committee, the Committee on Ministry, the Nominating Committee, the Program Committee, the Finance Committee, and the Hua Mua Committee. Each committee will follow their Operating Policy & Procedures following board approval. The Board of Directors or the Association may appoint Special Committees as deemed advisable.

6.1 **EXECUTIVE COMMITTEE** There shall be an Executive Committee composed of the Luna Ho'omalū, Luna Ho'omalū Hope, Kākau 'Ōlelo, Pu'ukū, and Papa Makua.

6.1.1 The Executive Committee shall meet as needed. The Luna Ho'omalū may call special meetings. A minimum of three or more of the Executive Committee shall constitute a quorum.

6.1.2 The Executive Committee shall be the instrument of the Board of Directors between Board meetings and is empowered to carry out the duties of the Board and/or the Association.

6.1.3 The Executive Committee shall be no more than one (1) Executive Officer per membership church.

6.2 **COMMITTEE ON MINISTRY**

6.2.1 The Committee on Ministry shall consist of seven (7) members; three (3) of whom shall be lay persons, and shall include one or two (1–2) persons from each island as stated in Article 4.1.2 Members shall serve staggered terms, shall be nominated by the Nominating Committee, and elected at the 'Aha Nā Kai 'Ewalu. Members shall serve a term of three (3) years beginning July 1 of the year elected and may serve no more than two consecutive terms. In the

event of a vacancy, the Board of Directors shall appoint a replacement to complete the unexpired term.

6.2.2 The Committee on Ministry shall decide upon the frequency of meetings. It shall be responsible for matters relating to Kahu; Members in Discernment; ordination; granting, maintenance, transfer, and termination of ministerial standing; privilege of call; installation; commissioning; and granting, maintenance, and termination of local church standing; and shall, refer to applicable portions of the Buke Lawelima with reference to the Manual on Ministry as needed and respect Hawaiian Cultural Values make appropriate recommendation (s) to the association.

6.2.3 The Committee on Ministry, through development of programs for professional growth, continuing education, personal support and denominational relationships, shall be responsible for matters relating to the support of the Kahu in the Association and the recruitment and nurturing of students of Hawaiian ancestry interested in entering the ministry, as defined in Section 1.2.2 hereof.

6.3 NOMINATING COMMITTEE The Nominating Committee shall consist of three (3) members and be appointed by the Board of Directors to serve staggered terms of two (2) years each beginning on July 1 of the year appointed.

6.3.1 The Nominating Committee shall nominate one or more candidates for the offices of Luna Ho'omalulu, Luna Ho'omalulu Hope, Kākau 'Ōlelo, and Pu'ukū; one or more candidates for island representatives to the Board of Directors; and one or more candidates for the Committee on Ministry.

6.3.2 The names of the nominees, with information of their qualification, shall be submitted to member churches no less than one (1) month before the Annual Meeting.

6.3.3 Nominations may only be made from the floor at the Annual Meeting, if there is a vacancy in a position at that time, a second is provided, and motion approved by the body.

6.4 FINANCE COMMITTEE

6.4.1 There shall be a Finance Committee consisting of three (3) members, appointed by the Board of Directors to serve staggered terms.

6.4.2 The appointed term shall be three (3) years.

6.4.3 The Pu'ukū shall be an ex-officio member of the Finance Committee with the right to vote.

6.4.4 The Finance Committee shall present an Annual Budget to the Board of Directors for the next fiscal year.

6.5 NA LIMA HO`IKE E PROGRAM COMMITTEE

- 6.5.1 There shall be a Program Committee of seven (7) members, one (1) from each of the islands of Hawai'i, Maui, Moloka'i, 'Oahu, and Kaua'i, and one (1) youth delegate under 35 years of age, plus a representative from a recognized Partnership Ministry of this Association.
- 6.5.2 Each member of the Program Committee will serve a staggered three (3) year Term.
- 6.5.3 The Program Committee members shall help the local churches develop programs.
- 6.5.4 The program committee will review and evaluate the grant applications.
- 6.5.5 The grant applications that are denied will be presented to the BOD for final consideration.

6.6 HUA MUA COMMITTEE

The Hua Mua Committee exists to ensure that the Association of Hawaiian Evangelical Churches is truly self-governing and financially self-sustaining as written in the mission statement.

- 6.6.1 **COMMITTEE MEMBERS** Committee will be composed of five (5) members with terms of three (3) years that are staggered, or until replaced. Committee shall consist of a Chairperson, Secretary, and Three (3) at large members.
- 6.6.2 The Papa Makua and Pu`ukū are ex-officio members of the committee.
- 6.6.3 **PURPOSE** To develop capital campaigns to raise funds for financial sustainability and present proposed plans, visions, and recommendations to the Board of Directors.

6.7 SPECIAL COMMITTEES

- 6.7.1 Special Committees may be created by the Association or the Board of Directors to fulfill the purposes of the Association and/or represent the Association in other affiliated and/or non-affiliated organizations.
- 6.7.2 Duties and functions of the Committee will be delineated by the Board of Directors.
- 6.7.3 The term of the Committee will be determined at the time of formation.

- 6.8 CHAIRPERSONS** One member of each committee may be appointed chairperson by the Board of Directors of this Association, and/or to consider a committee recommendation.
- 6.9 QUORUM** Unless otherwise provided in the resolution of the Board of Directors designating a committee, a majority of the whole committee shall constitute a quorum and the act of a majority of the members present at a meeting at which a quorum is present shall be the act of the committee.
- 6.10 RULES** Each committee may adopt rules of its own government not inconsistent with these Bylaws or with rules adopted by the Board of Directors.

ARTICLE VII-INDEMNIFICATION OF OFFICERS AND DIRECTORS

- 7.1 INDEMNIFICATION** Any person who is made a party to any action, suit or proceeding, civil, criminal, administrative or investigative, by reason of the fact that such person is or was a director, officer, committee member, or a member of a member Church serving in a position at the request of the Association , shall be indemnified by the Association against the expenses (including amounts paid by way of judgement, and settlement and including attorney's fees) reasonably and necessarily incurred by him or her in connection with the defense of such action, suit, or proceeding, whether or not such defense shall be successful in whole or in part, or in connection with any appeal therein, or any settlement thereof, except in relation to matters as to which it shall be adjudged in such action, suit, or proceeding that such person is liable for willful misconduct in the performance of his or her duties.
- 7.2 AUTHORIZATION** Unless ordered by a court, any indemnification under Section 7.1 of this Article shall be made by the Association only if authorized in the specific case upon a determination that indemnification of the director, officer or committee member has met the applicable standard of conduct set forth in Section 7.1. The determination shall be made (a) by the Board of Directors by a majority vote of a quorum consisting of Directors who were not parties to the proceeding; or (b) if a quorum is not obtainable, or, even if obtainable if a quorum of disinterested directors so directs, by independent legal counsel in a written opinion to the Association; or (c) by a majority vote of the members; or (d) by the court in which the proceeding is or was pending upon application made by the Association or the director or officer or the attorney or other person rendering services in connection with the defense, whether or not he application by the director, officer, attorney, or other person is opposed by this Association.
- 7.3 ADVANCE PAYMENTS** Expenses incurred in defending any proceeding may be paid by the Association in advance of the final disposition of the proceeding as authorized by the Board of Directors in a particular case upon receipt of an undertaking by or on behalf of the director or officer to repay such amount unless it shall ultimately be determined that the director or officer is entitled to be indemnified by the Association as authorized in this Article VII.

- 7.4 OTHER RIGHTS** The indemnification provided by this Article shall not be deemed exclusive of any other rights to which those indemnified may be entitled and shall continue as to a person who has ceased to be a director or officer and shall inure to the benefit of the heirs and personal representatives of such a person.
- 7.5 INSURANCE** The Association shall have the power to purchase and maintain insurance on behalf of any director or officer of the Association, against any liability asserted against or incurred by the directors or officer's status as church, whether or not the Association would have the power to indemnify the director or officer against liability under this Article.

ARTICLE VIII-EXECUTION OF INSTRUMENTS

- 8.1 PERSONS AUTHORIZED** Except as may be otherwise provided in the Constitution and Bylaws, or by resolution of the Board of Directors or by law, the person authorized to make and execute all written instruments of Association, including the checks, drafts, notes, bonds, acceptance, deeds, leases, and contracts shall be the Luna Ho'omalua (President), the Luna Ho'omalua Hope (Vice President), the Kākau 'Ōlelo (Secretary), the Papa Makua (Spiritual Leader), and the Pu'ukū (Treasurer).
- 8.2 CONTRACTS** The Board of Directors may authorize any officer or officers, agent or agents of the Association, in addition to the officers so authorized by these Bylaws, to enter into any contract or execute and deliver any instrument in the name of and on behalf of the Association, and such authority may be general or confined to specific instances.
- 8.3 CHECKS, DRAFTS, ORDERS, AND NOTES** All checks, drafts or orders for the payment of money, notes or other evidences of indebtedness issued in the name of the Association, shall be signed by such officer or officers, agent or agents of the Association, and in such manner as shall from time to time be determined by resolution of the Board of Directors. In the absence of such determination by the Board of Directors, such instruments shall be signed by any officer if the amount of the instrument is under one thousand dollars (\$1,000), or by the Pū'ukū and countersigned by the Luna Ho'omalua, the Luna Ho'omalua Hope, the Kākau 'Ōlelo or the Papa Makua of the Association if the amount of the instrument is one thousand dollars (\$1,000) or over.

ARTICLE IX-FINANCIAL MANAGEMENT

- 9.1 BUDGET** A proposed Annual Budget as presented by the Finance Committee, approved by the Board of Directors, and distributed to the churches together with the notice of the Annual Meeting.
- 9.2 RECEIPTS**
- 9.2.1 Uku Kumau (Dues)** Each church member, as defined in Section 1.1.1.1 hereof, shall pay annual per capita assessment based on the total number

members of that church. The Association shall establish the rate of assessment.

- 9.2.2 **Lulu (Offering)** An offering may be received at meetings of membership to support the work of the Association.
- 9.2.3 **Fund Raising** The Association may undertake special fund raising activities approved by the membership or Board of Directors.
- 9.2.4 **Deposits** All funds of the Association shall be deposited from time to time to the credit of the Association in such banks, trust companies, or other depositories as the Board of Directors may select.
- 9.3. **DISBURSEMENTS** All disbursements shall be paid by the Pu'uku (Treasure) as may be directed by these Bylaws, the Board of Directors, or this Association.
- 9.4. **AUDITS** Within ninety (90) days after the close of each fiscal year, the Pu'ukū will submit to the Board of Directors an annual financial statement prepared in-house and verified as to accuracy by an authorized officer or member of the Board, who shall be appointed by the Board of Directors. Findings will be reported to the membership at the next meeting of the Association.
- 9.5. **GRANTS AND ENTITLEMENT** The Association may appoint a special committee to search and investigate grant and entitlements that may be available to the Association.
- 9.6. **GIFTS** The Board of Directors may accept on behalf of the Association any contribution, gift, bequest, or devise for the general purposes as for any special purpose of the Association. The Board may appoint a Special Committee to receive and manage endowments and special gifts.

ARTICLE X-BOOKS AND RECORDS

The Association shall keep correct and complete books and records of account and shall also keep minutes of the proceedings of its members, Board of Directors and Committees having any of the authority of the Board of Directors, and shall keep at the registered or principal office a record giving the names and addresses of the members entitled to vote. Any member, or his agent or his attorney may inspect all books and records of the Association for any proper purpose at any reasonable time.

ARTICLE XI-FISCAL YEAR

The fiscal year of the Association shall be from July 1 through June 30.

ARTICLE XII-PARLIAMENTARY AUTHORITY

All meetings of the Board of Directors, Committees, and the Association shall be conducted in accordance with the latest edition of Robert's Rules of Order, which shall be the parliamentary authority for all matters of procedure not covered by the Constitution or the Bylaws of this Association, as amended.

ARTICLE XIII-AMENDMENT AND REVIEW

These Bylaws may be altered, amended, or repealed and new Bylaws may be adopted by a majority of the members present at any regular meeting or at any special meeting, if at least thirty (30) days written notice is given of the intention to alter, amend, or repeal or to adopt new Bylaws at such meeting. These Bylaws shall be reviewed every three (3) years.

AHEC Ho`ola I Ka `Aina Komike (Land Research Committee) Report
Aha Nā Kai `Ewalu, June 11, 2026

“The land must not be sold permanently, because the land is mine and you reside in my land as foreigners and strangers.” (The Year of Jubilee: Leviticus 25:23)

The goals of our Ho`ola I Ka `Aina Komike remain:

To research the titles of our AHEC churches to determine who owns the land.

To research the history of the land of the HCUCC (Hawai`i Conference of the United Church of Christ).

One of our AHEC churches wrote to us requesting help in obtaining a certified copy of the deed to their church held by the Hawaii Conference Foundation and other documents related to the land on which the church sits. The request was forwarded to the Hawaii Conference Foundation, which responded positively. The AHEC church needed a copy of the deed to apply for a loan from The United Church of Christ Cornerstone Fund. This is an example of our committee working together with the Hawaii Conference Foundation.

Mr. Laakea Kamakawiwoole has done research on his Kalemela Church in Honokaa. He was able to research into files of the Hawaiian Kingdom for some primary resources. He has agreed to lead a workshop of our committee in how he was able to research this material while he continues to gather information of churches that incorporated under the Kingdom of Hawai`i. Interested people can contact our committee.

The Great Mahele of 1848 was done during the reign of Kauikeaouli (Kamehameha III). Dr. Ronald Williams Jr. in his Project Mo`i series, will lead a free online course. One can register for this course with resources at <https://forms.gle/mdsSfVcbBDS8eeb1A>. This is a great opportunity to learn some important history related to the modern land system initiated in Hawai`i.

Our committee has been receiving a few requests to help with the identification of land title questions from a few churches.

Report of the AHEC Ho`okolokolo sub-committee on Boarding Schools
Aha Nā Kai `Ewalu, June 11, 2026

Latest news on the CAIM/AHEC Justice Task Force:

The dates of the first in-person organizing meeting of the task force in Black River Falls, Wisconsin has been decided: October 10-12, 2026 (traveling days Oct. 9th, 13th)
Hosting will be the Hocak UCC Church (AKA the HoChunk UCC). Meeting will be in the Ho-Chunk Tribal building, District 1 Community Center.

The Neighbors in Need (NIN) grant of \$5,000 awarded to the Hocak UCC proposed an initial in-person meeting of the task force to be formed by 4 representatives of CAIM (2 from the Hocak UCC) and 4 representatives from the AHEC with other invited supporters.

Papa Makua chose as the AHEC representatives: himself, Pualani Muraki, Laakea Kamakawiwoole, Ronald Fujiyoshi. At the last planning committee meeting all four of us were present by Zoom. The planning committee meets about every two weeks. Since the cost of the first in-person gathering is estimated at \$15,000, the committee is still working at fund-raising. A Catalyst Grant of \$5,000 through the Wisconsin Conference UCC has been awarded to the task force, so with \$10,000 in hand, the in-person meeting will happen.

The first meeting of the CAIM/AHEC Justice Task Force will finally decide the structure and function of the task force. However, the planning team is suggesting a focus on the five resolutions submitted by CAIM and AHEC and passed at the General Synods of the UCC. The four CAIM/Hocak representatives are being decided; although Lawrence Littlegeorge and Libby Fairchild, Acting CAIM Director will be two of the four.

Due to scheduling changes and family obligations Lawrence “Larry” Littlegeorge and Cindy Rohland will not be leading a workshop at our Aha Na Kai Ewalu in June 2026.

Please keep our CAIM/AHEC Justice Task Force in your prayers as we boldly move forward in forming this historic relationship in working together to implement the justice resolutions brought to the General Synods of the United Church of Christ.

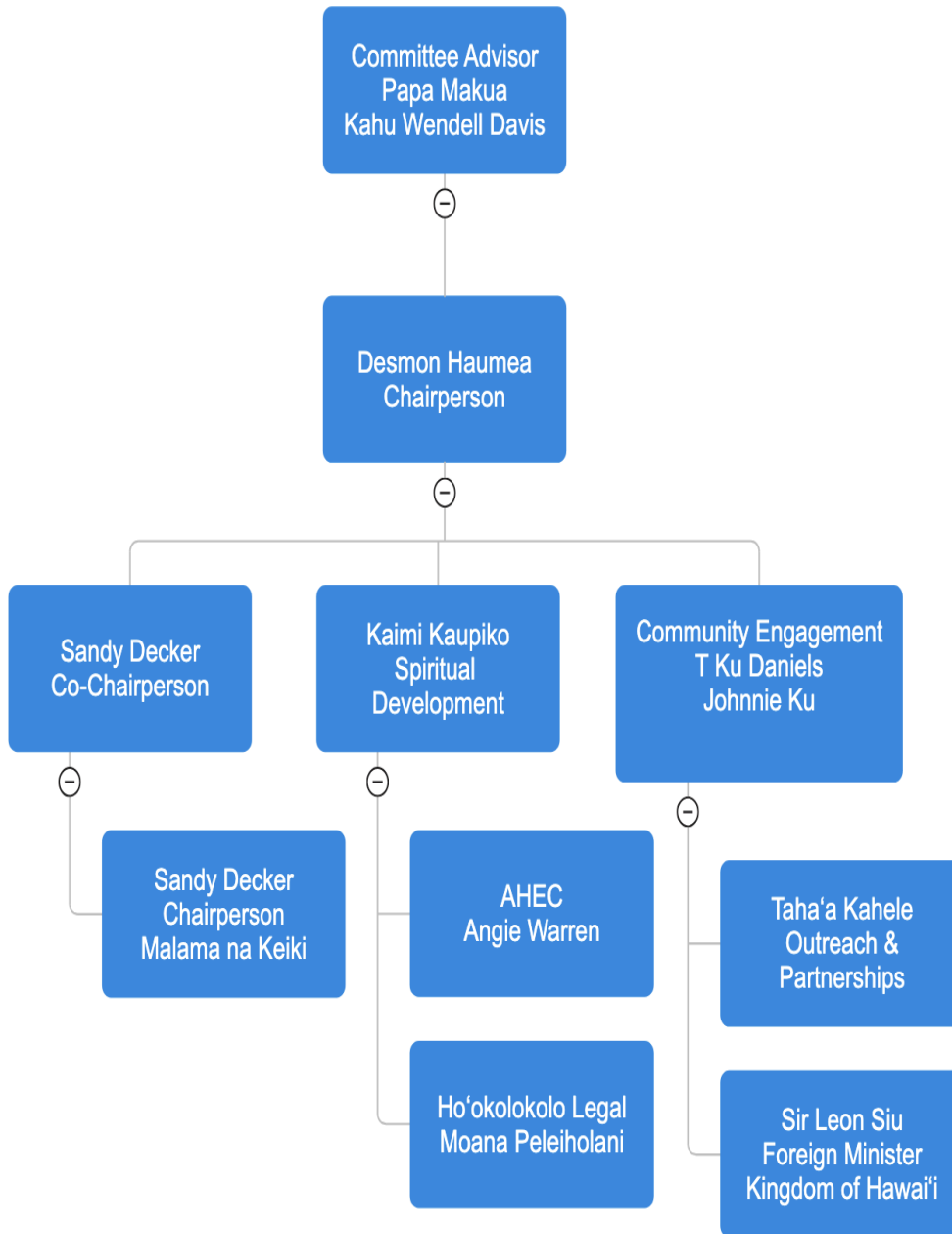

This year, we have expanded our AHEC churches on Kauai from one church to two. Waimea Hawaiian Church joined AHEC earlier this year.

Waimea Hawaiian Church

Waimea Hawaiian Church joined AHEC this year, but the Kauai Representative was unable to contact them to get an update for the report.

Koolauhuiia Protestant Church

Koolauhuiia Protestant Church remains a small but faithful congregation committed to worship, community presence, and stewardship despite significant challenges. The church is supported by an active Board of eleven members who continue to guide ministry efforts and maintain operations.

In the past year, congregational life has been strengthened through the introduction of a weekly fellowship hour following Sunday worship, along with special gatherings during major holidays. These efforts have helped build connections and sustain morale within a small and aging membership, where average weekly attendance ranges from 8 to 20, with larger participation at special events. A new roadside sign and the launch of a church website (<https://www.koolauhuiiachurch.org/>) have improved visibility and outreach, while also enabling online giving.

However, the church faces significant infrastructure challenges. The church building, now over 60 years old, requires extensive repairs, most urgently a full roof replacement due to water damage and termite-compromised structural elements. Other needed improvements include septic installation, kitchen upgrades, and general restoration. Efforts are ongoing to secure permits, gather bids, and pursue grant funding, though financial resources remain limited. A capital campaign has raised some funds and awareness, and we were able to secure grants through the SCHCC’s “Small Churches” fund and the Antone & Edene Vidinha Trust, but we are still significantly short of our goal. Potential partnerships, including with a local trade academy, are being explored to reduce costs.

The parsonage, previously rented, has been taken out of service to evaluate its use for pastoral housing, but it too requires substantial repair. This has directly impacted the church’s ability to secure consistent ministerial leadership. Currently, worship is maintained through a combination of visiting clergy, lay speakers, and monthly leadership from Kahu Kordell Kekoa. While this has sustained regular services, the absence of stable pastoral leadership remains a major concern.

Financially, the church continues to operate under strain due to limited membership, rising expenses, and increasing insurance costs. While current obligations are being met, reserves will be needed for upcoming repairs. Administrative progress has been made with updated financial reporting and improved recordkeeping.

Additional challenges include new legal requirements affecting historic burial sites on church property, which currently prevent active burials without extensive and costly compliance measures.

Despite these obstacles, Koolauhuiia remains committed to its mission. Through continued worship, community outreach, and careful stewardship, the congregation seeks to preserve its presence and ministry while actively pursuing solutions for long-term sustainability. The church is deeply grateful for the ongoing support and partnership of the wider conference community.

Lāhuiokalani Ka'anapali was spared damages except for the doors that swelled because of the prolonged rain.

Because of the 2023 Lahaina fire, we continue to provide a place of worship for the Filipino and Tongan congregations of King's Cathedral as well as the Spanish speaking congregation for the Pentecostal Church. In March, the Lahaina United Methodist Church returned to their campus, where there is temporary structure for worship. The rebuilding process will take years to finish.

On Easter Sunday, we welcomed 72 worshippers: 5 families with children aged 4 to 20 years. We had just enough elements for Holy Communion! Waiola Church continues to navigate this period of recovery with faith, resilience, and a deep commitment to serving both our congregation and the Lahaina community. We were graciously donated funds by a Senior Church Member to purchase a large tent which is semi-permanently installed and made through the last storms. We set up chairs and meet the first Sunday of every month under the tent.

Our Easter service was well attended with 49 children and adults, both members as well as visitors. One member took the initiative to make an egg hunt and hand out goody bags thru the Salvation Army. The Kukahiko 'Ohana prepared a meal for after service that was very, very yummy and was enjoyed by everyone.

We remain mindful of the realities our members and community are facing. Many families continue to experience housing instability, financial hardship, and uncertainty as rebuilding efforts across Lahaina remain slow and complex. The emotional and spiritual toll of this prolonged recovery continues to be felt.

Waiola Church continues to move forward in our rebuilding efforts. We are working with a project manager to guide the process and ensure responsible planning and coordination. At this time, we are in the phase of identifying and selecting an architectural firm. Proposals have been received, and leadership is actively reviewing and discerning the best fit for Waiola's needs, values, and long-term vision.

We continue to prepare our Luakini street property that used to house Waiola church members and our plans include installing modular homes that they can come home. The recent passing of our Deacon Ka'aina Kauhane leaves a space open as he planned to move home to where he lived for decades on our property, back when Luakini street was called Chapel Rd. He will be truly missed, and we will keep moving forward knowing he is with our loving God watching over us.

These are significant steps forward, though the process remains careful and deliberate. We continue to have faith in the process of which God has in store for us and we persevere.

We now have a Maui Music Festival series on our property every last Thursday of the month. It is organized by Lahaina Restoration, and we are able to provide them with the space to have this event for Lahaina as a welcomed and healthy option in healing and fellowship for our greater Lahaina community.

We are grateful for the continued prayers, partnership, and support from all as we move together in hope. Anastasia Arao-Tagayuna, Moderator and myself.

Historical Standing

Luakini o Kalemela continues its restoration and ministry work as a historic Hawaiian Kingdom church originally chartered in 1860 under Ekalesia o Pa‘auhau, Hāmākua. Historical records published in *Nupepa Kuokoa* recognize the establishment of the church during the reign of King Kamehameha IV.

Our congregation honors the legacy of our kūpuna who upheld faith, aloha ‘āina, and the rights of the lāhui through generations of change and hardship. We continue to recognize the enduring spiritual and historical responsibilities entrusted to the churches and communities of Ko Hawai‘i Pae ‘Āina.

Restoration & Ministry Update

Throughout 2025–2026, Kalemela has continued restoration planning and organizational development to preserve the church structure, grounds, and historical records for future generations. Current efforts include assessment and planning for structural stabilization, steeple and bell restoration, protection of church lands, and long-term stewardship planning.

The ministry has also expanded community outreach through prayer gatherings, cultural education, genealogy preservation, and discussions surrounding the historical role of Hawaiian churches within their communities. Historical trust and church structure research continues as part of preserving the original purpose of these Hawaiian Kingdom era congregations.

Fellowship & Unity

Kalemela remains thankful for the fellowship extended through the churches of the ‘Aha Nā Kai ‘Ewalu and the broader Hawaiian church community. We believe the restoration of our churches is not only physical, but spiritual and relational — strengthening unity among congregations, protecting sacred places, and ensuring that future generations inherit living houses of worship rooted in faith, truth, and aloha.

We respectfully encourage continued cooperation between churches, lineal families, and communities in preserving the legacy of our kūpuna and supporting one another in ministry.

Kaimu/Kalapana Hale Pule: We continue our services at the facilities of Uncle Robert's Farmers Market and `Awa Bar at the invitation of the Keli`iho`omalua `ohana. Every Sunday we provide lunch for those in need in the area. One person said it is the only hot meal of his week.

We continue to go through the building permit process for the Marae Village project. We have the grading permit and are working on final grading. Each village will have a Hale Pule. See attached Newsletter.

We ministered at the Wiconi Native American Conference and Pow Wow in Oregon and at the Flathead Reservation in Montana. We hosted Maori at the Marae Village property house for 3 weeks. We were plenary speakers at the Sacred Assembly of Canada. See attached Newsletter for details and at the Maori led Gathering of Eagles conference in Aotearoa. We taught missiology and Hawaiian history in Kona and at several seminaries/mission bases in Montana, Aotearoa, on the Big Island and Oahu. Planning more teaching on Oahu, Big Island and Kauai. Took a group of 16 Hawaiians to Aotearoa to learn from Marae Villages. Went to Alaska in April. This is a short report: In Alaska, met many people who had children and young family members commit suicide. Alaska has the highest teen suicide rate in the US. Most are native. Jesus is the answer they need. The young people are looking for their identity and dignity but have not found it in the church. There is only one person who choreographs and dances Inupiaq Christian dance. It is like where Hawaii was 32 years ago when we started and no hula was allowed in church because it was evil. What an honor to be a part of breaking them free to find Jesus in the Spirit and Truth of who they are. This person who is the only one who choreographs and dances Christian Inupiaq dance, Suzzuk, is a respected Inupiaq language and cultural educator. She was invited to 5 other meetings that night. We prayed that she would come to ours. She prayed and felt she should come to our presentation. I taught about how/why throughout scripture culture was used to bring people to Jesus. Yolanda danced and I asked her to dance and explain her dance (most do not know their language anymore). She is one of the main forces behind bringing their language and culture back. As she shared her journey to be an Inupiaq Christian and her rejection from the churches, she said she did not expect to weep. But others in the audience were weeping with her. After she danced another respected elder went to her and they wept together. The village leader was there as well as one of the most influential Inupiaq Christian elders who had been against dance and using their drum. We were so blessed to be a door opener for them to find their dignity and identity in Christ. It is all about love, that God loves who He made them to be. She said I shared what she had been trying to share with the churches in such a scriptural and simple way. She wants me to share at her denominational conference. We also shared at the denominational conference of one of the most influential denominations in Alaska that had forbidden their dance and drum. We saw great breakthroughs there. We also shared at a church, several other gatherings and with many church leaders. God is so good to His servants! We came back with many precious gifts made by the grateful people of the land and priceless experiences. After surfing most of my life, they set me up to drive a snowmobile through snowy Noem and then a mile out on the frozen ocean to

help bring in crab pots through holes cut through ocean ice. Fresh king crab for lunch, so much better than frozen! I also got to pack Yolanda on a snowmobile through Shaktoolik village, high snow banks, falling snow and onto the frozen ocean. Just a few of the priceless experiences given to us by grateful people. God is Good!

Christian Voice of Hawaii Report to AHEC
Report for ‘Aha Nā Kai ‘Ewalu
June 11, 2026

Besides being the founder and Director of Christian Voice of Hawaii, I also serve as the Minister of Foreign Affairs for the Hawaiian Kingdom, a position I have held for the past 26 years.

The primary work of Christian Voice of Hawaii in 2025 with regard to AHEC, has been to represent AHEC’s position of advocacy for Hawaii’s sovereignty with an immediate focus on the Pacific Islands ministries and governments.

In early March, I attended a five-day Global Consultation on Self-Determination and Decolonization in Pape‘ete, Tahiti, where I presented a paper titled, *Self Determination Process of Hawaii: Challenges and Prospects*. Our presence there raised the visibility and credibility of our movement to free Hawaii. It also clarified the attendees’ understanding of the unique nature of Hawaii’s situation and our approach to resolving the long-standing hewa with Aloha.

This past month (April) I visited New York City where I ...

- Had bi-lateral meetings with several Ambassadors of Pacific Islands member states to the United Nations to discuss each country’s interest in helping to initiate a resolution calling on the UN General Assembly to review UNGA Resolution 1469. Each felt it was time for us to speak directly to “their capitals” (their nation’s leaders) to get approval to proceed with drafting and submitting of the resolution. Each offered to facilitate the meetings with their capitals which will take place in June and July 2026.
- Attended the first meeting of the Working Group for Self Determination (WGSD), a sub-committee that I initiated under the aegis of the 500+member CoNGO (the Conference of NGOs in Consultative Relationship with the United Nations).
- Met with members of the Hawaii diaspora to create a support group for upcoming advocacy activities at the UN.
- Promoted and attended the screening of the film, *Lāhainā Rising* at the UN Permanent Forum on Indigenous Issues.

Strong interest has been expressed by several other non-Pacific UN member states in pursuing international initiatives to assist Hawaii in confirming our status as a sovereign, independent nation in continuity. We are pursuing these international initiatives.

I request the Board of AHEC to please consider providing some funding to underwrite travel expenses to pursue these initiatives. Please get in touch with me.

200 keiki served through CarePortal!

Kokua Closet- 316 keiki (102 boys, 214 girls) registered to shop w/QR Code - Shoppers at University Avenue Baptist Church & Central Baptist Church. These numbers reflect shoppers that filled out our online sign-in form.

As of March 1, 2026, Harvest Family Life Ministries Hawaii has been granted a contract with the State of Hawaii Department of Human Services Social Services Division. Recruitment of Resource Caregivers (Foster Families) for the entire state! To our knowledge, this is the first time ever that a Gospel-centered, Christian organization has been granted a contract with Child Welfare Services in our state! There have been faith-based partnerships, but those contracts were given to local "secular" non-profits. Years of prayer, partnership, loving like Jesus, and just consistently "showing up" has led us to this place.

This moves us closer to achieving our vision of More Than Enough! Now we will meet/know every individual and family who is considering applying to be General Licensed to provide safe, loving homes for keiki in foster care in Hawaii and most of the hanai/kinship care homes as well. CHURCH-we can NOT do this without you! How will we answer God's call?

We are excited, celebrating, and praising God. We ask that you pule with and for us-now the State is saying to the local Body of Christ, "Church, we need your help!" Please Pule-the Church (statewide) is now challenged to Rise Up and serve the State and vulnerable children & families with the Love of Jesus to a greater extent than ever before. There is still a disproportionate amount of Native Hawaiian children in Hawaii's foster care system compared to other ethnicities. **Is your church willing and able to host a foster care presentation?**
